**CELTIC ANNOUNCES \$24.975 MILLION BOUGHT DEAL FLOW-THROUGH FINANCING**

Celtic Exploration Ltd. ("Celtic" or the "Company") has entered into an agreement with a group of underwriters, led by FirstEnergy Capital Corp. and including BMO Nesbitt Burns Inc., GMP Securities L.P., TD Securities Inc., Orion Securities Inc., Peters & Co. Limited, Tristone Capital Inc., Canaccord Capital Corporation and RBC Capital Markets to issue by way of private placement, 1.5 million flow-through common shares of the Company at a price of \$16.65 per share. The offering will result in gross proceeds of \$24.975 million.

The offering is subject to approval by the Toronto Stock Exchange and closing is expected to occur on or about February 27, 2007. Proceeds from the offering will be used to fund Celtic's capital program and will be spent in 2007. The Company's 2007 capital expenditure program will be increased from \$130 million to \$140 million.
